Dear Friends,

During the 2024 - 2025 school year, the Council on Child Abuse (COCA) delivered safety presentations to nearly 24,000 children in 1,163 classrooms across 87 schools — continuing our dedication to preventing and stopping child abuse and bullying where children live, learn, and play.

Our presentations provide a safe space for students to share their concerns and seek help. During the last school year, 455 students met with trained counselors with 61 of those students' cases being referred to Child Protective Services.

This year's Reach for the Stars event, held in April to honor National Child Abuse Prevention Month, raised more than \$73,000 in support of COCA's programs and services.

Our continued impact is only possible through the generosity and dedication of our incredible community. As we remain focused on advocacy, education, and fundraising efforts that sustain our mission, we extend our heartfelt thanks to our donors, volunteers, and staff for making this year a success. Together, we are building a safer, stronger community for every child.
