



Council on Child Abuse Annual Report 2021-2022

Dear Friends,

This past year, the Council on Child Abuse (COCA) continued to respond to the evolving needs of educators, parents and students related to the delivery of its presentations. COCA tailored in-person presentations to include health and safety protocols, provided virtual sessions and created videos and curricula to be administered by classroom teachers. COCA's top priority is remaining adaptable and flexible to effectively educate as many children as possible about of child abuse and bullying.

During the 2021-2022 school year, COCA provided safety presentations to almost 20,000 children in 793 classrooms at 57 schools. And the students gained valuable insights:

- 98% of students recognize the types of abusive behaviors following classroom presentation.
- 99% of students recognize the safety rules following classroom presentation.
- 98% of students agree when asked if they think COCA's program would be helpful to other students their age.
- 100% of students who disclose trauma and/or abuse are referred for adult intervention.

With the support of our board, we focused on advocacy and fundraising. Our annual Reach for the Stars event returned in-person to recognize National Child Abuse Prevention Month and was our most successful event to date raising almost \$49,000 in support of our mission.

We thank our donors, volunteers and staff who made this year a success.
